Tip of the Month: Make sure your child has been vaccinated against Hepatitis A. Cases have been found in Ohio, Michigan, Indiana and Kentucky.

Patients MUST BRING:

1. Child's Paper Shot Record (*electronic copies not accepted*)
2. Child's Insurance Card (*if they have insurance*)
3. Parent's ID
