The Toledo-Lucas County Health Department is seeking a Nurse Practitioner to lead our Reproductive Health and Wellness Center, as funded through the Ohio Department of Health and Federal Title X of the Public Health Service Act. This program comprehensively addresses issues of reproductive health and wellness, including family planning, with a focus on populations in greatest need and identified priorities. An important goal of the program is to improve the overall health and well-being of women and men by promoting healthy lifestyles and encouraging the establishment of a reproductive life plan.

The Nurse Practitioner should possess the following:

- Master of Science in Nursing (MSN); or Doctor of Nursing Practice (DNP) required.
- Current, and active license as a Registered Nurse (RN) in the State of Ohio.
- Nurse Practitioner Board certified by AANP, ANCC or AACN, in Family Practice or Women's Health.
- Current CPR certification.
- Minimum 1 year clinical experience in reproductive health in a women's health or family practice setting.
- Knowledge of and ability to conduct services following generally recognized standards of care for advanced nursing practice in accordance with the most current rules adopted by the Board of Nursing for Advanced Practice Nurses.
- Carry automobile liability insurance and professional liability insurance, covering the services provided under the Reproductive Health & Wellness Center.

Responsibilities:

Reproductive health services are broad-based, voluntary and private. Services will include all aspects of reproductive health and wellness:

- Birth Control & Education
- Reproductive life planning, education & counseling
- Pregnancy Testing & Counseling
- Basic Infertility Services
- Pre-Conception Care
- STD Testing & Treatment
- Screening for Cervical Cancer
- Pap & Pelvic Exams
- Male Genital Exams/Screenings
- Referral services for other medical, psychological, or social services
- Basic Genetic Counseling

The Nurse Practitioner works as part of a team of health care and counseling professionals, providing clinical assessment and care to assigned patients on-site and within the community, following the Quality Family Planning (QFP) clinical recommendations model (www.hhs.gov).

The Nurse Practitioner agrees to provide services for the Reproductive Health & Wellness Center, and can expect:

- Part-time hours (0-20 hours per week) under contract (1099 Contractor)
- Traditional and non-traditional hours, to include one late night a week, and one Saturday a month, with hours or days dependent on patient demand. Must have availability on Tuesdays and Thursdays.
- A well-equipped examination and administrative work area on-site, with some direct care for specific populations to be conducted off-site within the community, on both a scheduled and walk-in basis.
- No on-call or holiday work required
