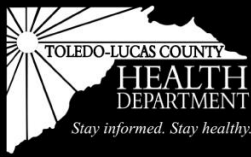
The COVID-19 numbers for Lucas County for today, April 15, are as follows:

- 627 total cases
  - 598 confirmed cases
  - 29 probable cases
- 28 deaths
  - 28 confirmed deaths
  - 0 probable deaths
- 289 male cases
- 338 female cases
- The ages range from 3 to 99

The deaths reported today represent one male in his 80s, one female in her 80s, and one female in her 70s.

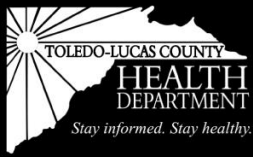
