Lucas County COVID-19 Update

The Lucas County COVID-19 numbers for today, are as follows:

- 3222 total cases
 - 3020 confirmed cases
 - 202 probable cases
- 290 deaths
 - 252 confirmed deaths
 - 38 probable deaths
- 1306 male cases
- 1916 female cases
 - Ages range from <1 to 109
- 29,897 total tests performed**

**Includes all (resident & non-resident) COVID-19 viral nasal swab tests performed in Lucas County (hospital & community testing sites). This number does not include Lucas County residents tested in other jurisdictions.

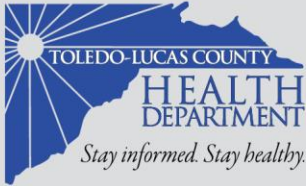
Under the Ohio Public Health Advisory System **Lucas County is an alert level 3 (red)**. Individuals in Lucas County must wear a facial covering/mask when they are out, per Ohio Department of Public Health order. Additionally, all recommendations should be followed:

- Decrease in-person interactions with others
- Consider necessary travel only
- Limit attending gatherings of any number

Follow good hygiene standards, including:

- Wash hands frequently with soap and water for at least 20 seconds.
- Use hand sanitizer frequently.
- Avoid touching your face.
- Cover coughs or sneezes (e.g., into a tissue or elbow).
- Symptom self-evaluation monitoring.
