**Lucas County COVID-19 Update**

The Lucas County COVID-19 numbers for today, are as follows:

- 3739 total cases
  - 3537 confirmed cases
  - 202 probable cases
- 293 deaths
  - 255 confirmed deaths
  - 38 probable deaths
- 1544 male cases
- 2195 female cases
  - Ages range from <1 to 109
- 31,175 total tests performed\*\*

\*\*Includes all (resident & non-resident) COVID-19 viral nasal swab tests performed in Lucas County (hospital & community testing sites). This number does not include Lucas County residents tested in other jurisdictions.

**Effective tonight, July 23 at 6 p.m., citizens in all Ohio counties will be under a mandatory mask order while out in public.**


Masks must be worn at all times when:

- At an indoor location that's not a residence
- Outdoors when unable to keep 6ft social distance from those not sharing a household
- When waiting for, driving, or operating public transportation such as a taxi, car service, or private rideshare.

Those who are 10 years old and older are required to wear a mask.

Statewide mask order exclusions include:

- Those with a medical condition or disability or those commuting with someone with a disability;
- Those who are officiants at religious services;
- Those who are actively involved in public safety; or
- Those who are actively exercising or playing sports;
- Those who are actively eating or drinking.
