Lucas County COVID-19 Update

The Lucas County COVID-19 numbers for today, are as follows:

- 5222 total cases
 - 5020 confirmed cases
 - 202 probable cases
- 304 deaths¹
 - 266 confirmed deaths
 - 38 probable deaths
- 2190 male cases
- 3032 female cases
 - Ages range from <1 to 109
- 38,417 total tests performed**

¹While 5 deaths are being reported in today's update, only 2 of those deaths occurred within the past several weeks. Death data can lag significantly and sometimes is reported to local health jurisdictions through death record investigations conducted by the Ohio Department of Health. When a death record lists COVID as a cause of death for individuals not in the Ohio Disease Reporting System, ODH reports these to the local health department. The nature of this process results in some deaths being reported long after the date of death for the individual. This is why all COVID data is considered preliminary until after the pandemic has ended.

**Includes all (resident & non-resident) COVID-19 viral nasal swab tests performed in Lucas County (hospital & community testing sites). This number does not include Lucas County residents tested in other jurisdictions.
